
The content of this directory has been standardized to the greatest extent possible and organized by the Department of Children and Families district.

We have attempted to list all significant efforts to assist homeless people in each community. Due to space constraints, however, we did omit certain entries relating to service provision that appeared to either be limited in scope or unrelated to homelessness. We regret any instance in which we failed to include important services or resources, and we welcome any suggested additions or modifications. We have received and hope to continue receiving many suggested edits. We will issue a supplemental edition of this guide with corrections and additions later in 2004. The guide should always be considered a work in progress.

The primary purpose of this guide is not to facilitate referrals, but rather to aid in the networking and communication between communities. Space constraints and differing technology have made it impossible to include critical information such as basic eligibility criteria and requirements that are necessary to ensure appropriate referral. However, the information may provide important contact information that will help homeless people access resources and services.
